Terms and Conditions

Flight Safety Australia annual subscription giveaway

1. General

- 1.1. CASA has 10 annual subscriptions to Flight Safety Australia magazine to give away (valued at \$39 each).
- 1.2. CASA is offering these subscriptions as Prizes in the Promotion.

2. Definitions

- 2.1. In these Terms:
 - (a) **CASA** means the Civil Aviation Safety Authority (ABN 44 808 014 470)
 - (b) **CASA's Head Office** means CASA's office at 16 Furzer Street, Phillip ACT.
 - (c) Entry means an individual who has completed the VFR communication and surveillance survey and has chosen to opt into the draw by sharing their information with us at the completion of the survey.
 - (d) **Survey** means the VFR communication and surveillance survey.
 - (e) **Initial Draws** means the series of draws described at clause 6.1.
 - (f) **Prizes** means the prizes described at clause 7.1.
 - (g) **Promotion** means the lottery CASA is conducting to encourage more completions of the Survey.
 - (h) **Promotion Period** means the period specified at clause 3.1.
 - (i) Redraw means, in relation to any unclaimed Prizes, a redraw for any unclaimed Prizes, which will be conducted as required under clause 9.
 - (j) **Terms** means the terms and conditions of Entry to the Promotion, as set out in this document.
 - (k) Unclaimed Prize means, in relation to a winning Entry for that Prize, any prize that remains unclaimed, or unable to be claimed, for any reason (e.g. because a winner cannot be contacted, cannot provide an Australian address for shipping purposes, or indicates they are unwilling to accept the prize) more than three months after the date of the Initial Draws or the Redraw in which the Entry was drawn.
 - (I) **Winner** means an Eligible person who holds a winning Entry.

3. Duration

3.1. The Promotion will commence at 9.00am on Wednesday 15 March 2021 and closes at 11.59pm on Sunday 15 May 2021.

4. Eligibility to enter

- 4.1. Entry is open to
 - Persons who completed Survey and chose to opt in by sharing their details as of 11:59 Sunday 15 May 2021.

but excluding any –

- (b) CASA employees
- (c) immediate family members of those employees
- (d) non-Australian residents.

5. Entry into the Promotion

- 5.1. Entry to the Promotion by opting in during the Survey is required by completing the last question and submitting personal details.
- 5.2. Entries received after the Survey Period will not be eligible for the Promotion.

6. Drawing of Entries

- 6.1. There will be 10 prize draws and each will take place at 9am, Friday 21 May 2021 at CASA's Head Office.
- 6.2. Entries will be randomly selected and each Winner will be awarded one of the 10 Prizes, as allocated by CASA.
- 6.3. The results of the Promotion and CASA's decisions on the allocation of Prizes are final, and no correspondence will be entered into.

7. The Prizes

- 7.1. As part of the Promotion there will be 10 Prizes. 10 randomly selected Winners will each receive an annual subscription to the Flight Safety Australia magazine valued at \$39.
- 7.2. All Prizes must be claimed within three months of the date of the Initial Draws or of the Redraw in which a relevant winning Entry was drawn.

8. Notification of winners and shipment of Prizes

- 8.1. All Winners will be notified by telephone or else by email.
- 8.2. CASA does not accept any liability for any Prizes damaged or lost during shipment.

9. Redraws

- 9.1. Where there are any unclaimed Prizes after the Initial Draws, CASA will hold a redraw for those Prizes from among the remaining Entries.
- 9.2. Where a Redraw under clause 9.1 is necessary, it will be held at 10am, Monday 23 August 2021 at the same place and in the manner described at clause 6.1.
- 9.3. Where there are any unclaimed Prizes after the Redraw, CASA reserves the right to randomly select another Winner by conducting another Redraw or using whatever other method it considers will deliver a fair and transparent result.

10. Variation of Terms

- 10.1. If any act, omission, event or circumstance occurs that -
 - (a) is beyond CASA's reasonable control, and
 - (b) prevents CASA from complying with these Terms.

CASA will not be liable for any failure to perform or delay in performing its obligations under these Terms.

10.2. CASA reserves the right (subject to any applicable law) to cancel, terminate, modify or suspend this Promotion without liability to any entrant or any other person.

11. Personal Information

- 11.1. Those who have provided their personal information in the final question of the Survey. One purpose for obtaining this information is to assist CASA in administering the Promotion.
- 11.2. CASA will use the personal information provided under clause 11.1 to contact Winners about their winning Entries.

- 12.1. CASA is conducting this Promotion as an exempt lottery, as defined by section 6(1) of the *Lotteries Act 1964* (ACT).
